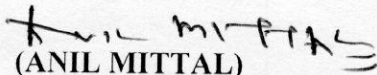

Sir / Madam,

1. This is in continuation to PCI's Circular dt.22.4.2023 & 27.6.2023.
2. In this connection, I am directed to inform that -
  - a) PCI has requested to all institutions which have applied first time to PCI through Google link provide by PCI between 26th April, 2023 to 5th may, 2023 for 2023-2024 academic session to do registration on PCI portal which will be opened form 28th June, 2023 to 10th July, 2023 by paying 10,000/-+ GST (one time registration charges) which will not refunded.
  - b) there was a technical issue in submitting the registration fee. Now technical issue is resolved hence another opportunity for registration on PCI Portal from 18th July to 24th July 2023 is provided to all new institutions.
3. The procedure for online registration is enclosed as **Annexure-1**.
4. In view of above, all institutions can now register by paying 10,000/- on portal between 18th July to 24th July, 2023.
