The Hon'ble High Court of Judicature at Allahabad (Lucknow Bench) vide judgement dated 22.9.2023 has quashed the impugned letter dated 18.5.2023 of the BTE and the consequential order.

  - a) as per Supreme Court judgement dt.5.4.2023 the last date to complete the approval process for 2023-2024 academic session was 30.8.2023 and appeal process was 30.9.2023.
  - b) some of the applications were pending in PCI office at that time. Hence office moved to Supreme Court for further extension of time.
  - c) Hon'ble Supreme Court vide judgement dt.6.9.2023 extended the time to complete approval process by 31.10.2023 and appeal process by 30.11.2023.
