With reference to the subject cited above, I am directed to inform that DPE examination scheduled to be held on 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> October 2024 is deferred for a future date as the matter is under approval of Health Ministry regarding change in scheme as proposed by PCI. On approval of the Ministry, further action will be initiated.

It is reiterated that candidates who have admitted in the 2022-2023 academic session in D.Pharm course and passed out in 2023-2024 academic session will register as a registered pharmacists until they qualify the Exit Examination and fulfil the other prescribed conditions u/s 32(2) of the Pharmacy Act, 1948.

In view of above, all applicants are advised to refer to the NBEMS website time to time for further updates in this regard.
