High Court in Cont. Case 1705 of 2023 and other connected matters whereby the Hon'ble Court had directed the Pharmacy Council of India to grant the approval to all institutions whose applications are pending for approval, though their deficiencies were communicated or not, subject to such institutions submitting an affidavit in 2 days with an undertaking to remove their respective deficiencies, if any, within a period of 7 days thereafter.

3. The Hon'ble President, PCI directed to take action in the light of the legal opinion received from Shri Ajay Kumar Singh.
4. Accordingly, the Council took the action with the approval of the Competent Authority.
