This is in reference to EoI published vide dated 16.07.2024 over the PCI website (<https://pcionline.co.in/>) inviting Expressions of Interest with proposals for the Empanelment of Central PSUs as an Implementation /System Integrator Partner. Further, PCI published subsequent corrigendum in regards to this EoI dated 25.07.2024 and 26.07.2024 with the last date for submission for the proposal as 05.08.2024. The EoI was published on the websites after the approval from PCI competent authority.

In view of this, the proposal opening invitation mail was shared by PCI to all the participating Central PSUs as listed below:

1. M/s NBCC (India) Ltd.
2. M/s Central Electronics Ltd.
3. M/s RailTel Corporation of India Ltd.

Further, the proposals were opened in presence of the authorised representatives from these Central PSUs and the technical evaluation committee in hybrid mode on 12.08.2024. Based on the documents submitted by these companies, PCI has evaluated all the documents and requested companies for the missing/incomplete documents with the clarifications from M/s NBCC (India) Ltd. and M/s Central Electronics Ltd. via mail dated 10.09.2024. Based on the observations listed by PCI, M/s NBCC (India) Ltd. and M/s Central Electronics Ltd. has submitted their clarifications and additional documents on 12.09.2024.


Therefore, based on the evaluation of all pre-qualification and clarification documents, PCI had released the results for the PQ Stage on website dated 24.09.2024. And further, both the compliant Central PSUs were invited for the technical presentations on 01.10.2024 at the PCI Office. Based on the presentations and other documents submitted in lieu of the criteria cited in the Technical Qualification stage, PCI is releasing the results of Technical Qualification Stage as cited below:
